This program/benefit is designed to support Westerville Area Chamber of Commerce members and their spouse/domestic partner in their continued educational pursuits. Westerville Area Chamber of Commerce members and their spouse/domestic partner can enroll as part-time undergraduate or graduate students and receive a discount reducing the cost per credit hour. This benefit is valid for one undergraduate or graduate degree per student. Graduate Certified Registered Nurse Anesthetist degree is <u>not</u> included in this benefit.

Benefit Eligibility:

- Be verified as a Westerville Area Chamber of Commerce member and/or member spouse/domestic partner at the time of admission.
- Meet degree/program admissibility criteria.
- Be registered for all classes for the term each year of enrollment by the deadline.
- Maintain a 3.0 GPA in graduate course work. Maintain a 2.75 GPA in undergraduate course work.

Coalition Discount Options for Member & Spouse/Domestic Partner:

• Students will receive a discount of 15% on the per credit hour charge.

Otterbein Discount Options for Member & Spouse/Domestic Partner:

• As a part-time student, receive a 15% discount on the undergraduate tuition credit hour rate for up to nine credits per semester.



FOR DEPENDENTS OF WESTERVILLE AREA CHAMBER OF COMMERCE MEMBERS

The Otterbein Advantage Scholarship for dependents of Westerville Area Chamber of Commerce members is available to any undergraduate prior to the age of 24 while still an IRS dependent and who has not completed a Bachelor's degree, whether they are applying as a **new** first-time first year student or a transfer student. Dependent children of members already enrolled at Otterbein are **NOT** eligible for this scholarship. The current value of this annual scholarship is **\$20,000 for a four year total of \$80,000.**

Scholarship Eligibility:

- Student must meet Otterbein admissibility criteria.
- Renewable for a total of eight semesters of undergraduate enrollment, or first undergraduate degree, whichever is achieved first.
- Replaces all other Otterbein academic merit non-need-based scholarships or grants of lesser value (need-based aid may still be available to eligible students).
- Student must enroll full-time each semester (12 hour minimum).
- Student enrolling for more than 18 hours per semester must pay for additional credits.
- Student must maintain a 2.75 Otterbein GPA and make Satisfactory Academic Progress for renewal.
- Student must complete Advantage Partner section of Common Application or provide notice to Otterbein of desire to participate in the Advantage Scholarship program at the time of application to be considered. Students will not be considered after the time of admission.
- Student's parent or legal guardian must be an member of Company at the time of admission.
